

**RULES AND REGULATIONS OF THE
ASSOCIATION GENEVOISE DE CRICKET
TWENTY20 COMPETITIONS**

PREAMBLE

These rules are an adapted version of Cricket Switzerland's rules and regulations for Twenty20 competitions. The amendments are made in view of allowing the Association Genevoise de Cricket (AGC) to exercise full organisational powers when setting up Twenty20 competitions, while maintaining the standards of the game as Cricket Switzerland commends so.

1 TWENTY20 CRICKET

1.1 Application of Rules

These rules apply to all Twenty20 format competitions run and specified by the AGC. These rules in no way supersede the Laws of Cricket, and the only variations from the laws allowed are those specifically permitted by these rules themselves. The allowed variations are in Appendix A.

2 SUPERVISION OF TWENTY20 COMPETITIONS

The general administration of Twenty20 format cricket is vested in the Cricket Switzerland League Championship Committee, hereinafter called the league committee, chaired by the league chairman who is elected at the Annual General Meeting (AGM). All decisions made by this committee are final and without any form of recourse. For Twenty20 competitions organised by the AGC, the AGC possesses subsidiary competence in terms of setting competitions format and size, match fixtures, team eligibility and entrance fee.

3 ADMINISTRATION

3.1 Finance

The size of the competition and entrance fee is set each year at the Annual General Meeting of the AGC.

3.2 Participation

Affiliate or associate members of Cricket Switzerland may play in Twenty20 competitions, as well as external teams invited by the Committee of the AGC.

3.3 Player Eligibility and Registration

Player eligibility and registration is governed by the Cricket Switzerland Premier League (CSPL) competition rules and regulations. For players coming from an external team, that is, not an affiliate or associate member of Cricket Switzerland, this rule is not applicable. In such instances, the external team has to register their players by providing their names, date of birth and gender to the AGC before the competition in which they participate takes place.

In case such balls are not available, only balls approved beforehand by umpires and both captains at the time of toss may be used in Twenty20 matches. A new ball shall be used for each innings. The ball used first on any day shall remain available at all times in case of a lost ball later in the day.
